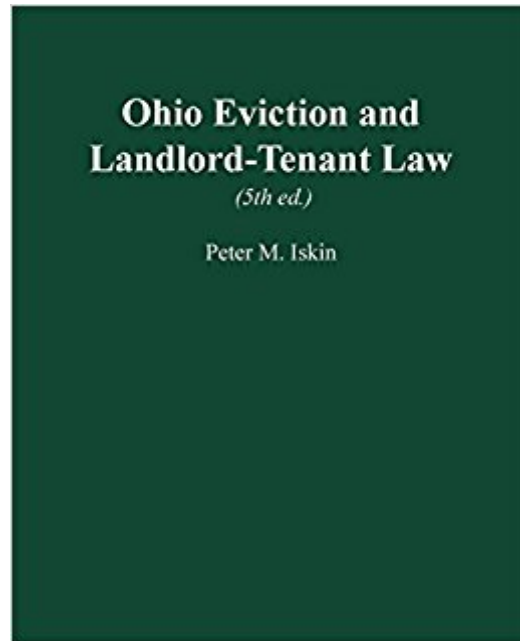

Like its predecessor, it is a complete and reasonably balanced presentation of statutory and case law on almost any issue a practitioner in this area could have a question regarding.
