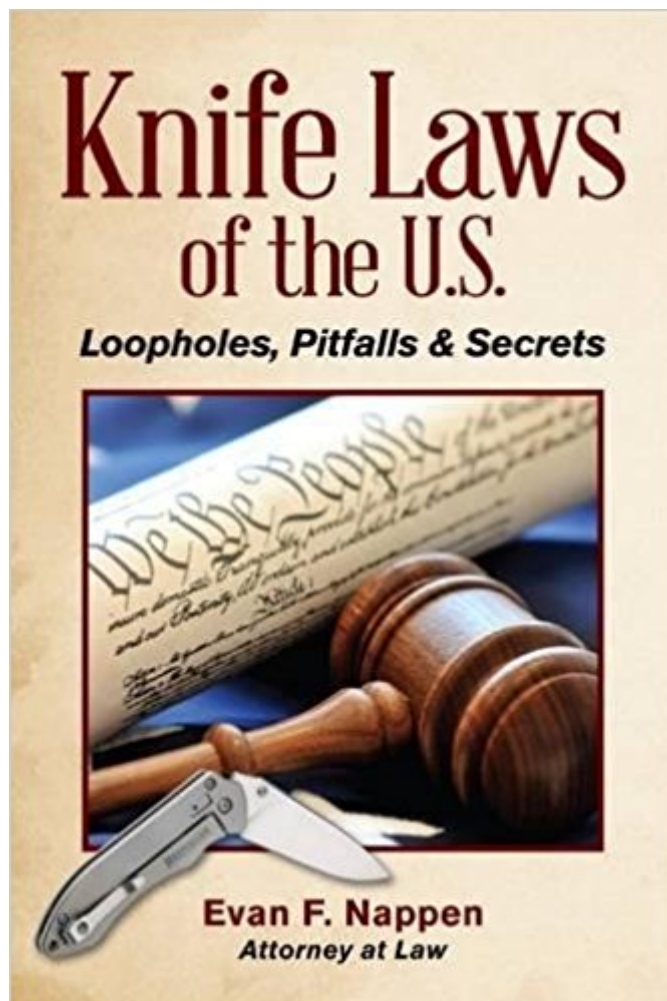

Evan F. Nappen, Esq. is one of the most respected legal authorities in the nation on the topic of knife law. As an attorney, Nappen has fought nationally for knife rights and has successfully defended honest citizens charged with knife crimes. He has authored an extensive list of books and magazine articles, and has appeared on CNN, Fox News, NPR, and many other news outlets. He lives and practices law in Eatontown, New Jersey.

The only negative I have for this book is isn't longer and/or isn't a direct feed into my brain. This is a must for anyone who carries knives for work or uses them as a tool, no matter what state you are in or what state you are intending to be in. Unfortunately as far as I know, a lot of this has changed

since the printing of this book (I haven't checked the publication year) but I recall Mr. Nappen (both of them) stating that many states are starting to strike down their existing knife laws on the books - expect NJ/NY/CT to be hold outs in this regard. This was as of May 2017. I don't recall which states, but you can find a video or two on YouTube of him discussing knife law at the NJ SAFE conference in the last year or two -- a highly recommend supplement to this. More about the book: The book isn't really broken up into chapters. It's broken up into sections for each state. Each state has a sort of "knife friendly" rating to it. The chapters are fairly cut & dry if you aren't familiar with legalese. Nappen is very precise with the information dolled out between sections & is consistent in what information is covered. Each section has a chart on what types of blades are legal, not legal, or in some sort of gray area making it quick & easy to determine what you should be aware of.

Excellent overview of the laws and associated references. Would have also liked more analysis of precedents set or cases litigated, where some laws are vague or in grey area in the tables provided. for example in NJ or PA possession in home of normally prohibited knives, like dirk dagger or auto seems possible for a collector.

Absolutely necessary knowledge for the knife carrier. Interesting rating for the various states. Intriguing information and a good read. Cudos to Evan F. Nappen.
